Fully automated SAP role build & maintenance

Supports the SAP role build and maintenance process: by documenting all security requirements centrally, the application can build all SAP roles automatically.

(Mass) role maintenance & simulation

The strength is that both organizational as well as non-organizational values (like movement & document types) can be used to derive roles on single and composite role level. Reverse engineering can be used to document the values. Simulation of impact, while performing mass role maintenance, provides full insight during the (mass) role building phase. CSI RBM supports simplification of a role concept, that business understands.

Auditing risks & SoD conflicts during role building

Audit the roles on risks and Segregation of Duty conflicts in the role design phase. A pre-defined ruleset with Segregation of Duty conflicts is included. Transaction codes and authorization values are checked separately to verify correctness of the roles.

Mass user maintenance

Mass user maintenance is included, this includes (mass) password resets, (mass) (un)locking and (mass) creation of users.

Remediating risks & SoD conflicts with impact analysis

Information of executed transaction gives insight for remediating the risks: directly remove the roles from users if they are not being used and directly adjust transactions and authorizations from roles that are not being executed by users. Changes on role content can be simulation on impact.

Track & solve role inconsistencies

Insight into role deviations between master and derived roles, deviations between role content and role descriptions, inconsistencies of assigned organizational and non-organizational values and correctness of role content.

SAP license audit

The license audit functionality provides insight into correct assignment of SAP user licenses. Multiple pricelists and cross-system overviews are possible.

Digital monitoring

Integrated transaction monitoring and access certification can be used to clean up roles. Comparison of results and role concepts over time provides insight into the cleaning process.

Mass profile maintenance

Includes functionality to (mass) maintain the SAP profiles. CSI RBM supports all role concepts, including ABAC and RBAC.

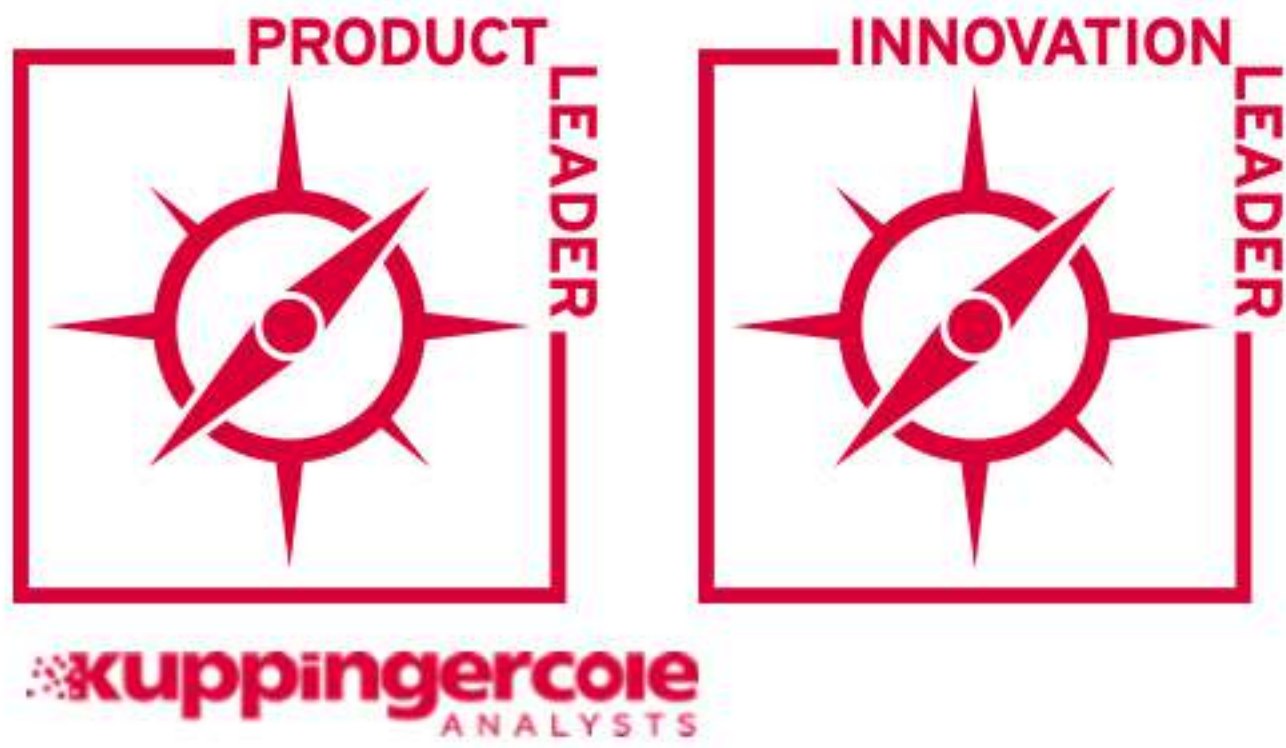
